BP respectfully requests an extension to June 2019 to run tubing in the subject well. Since BP is still opening the choke on this well, this initial request for 12 months is based on the performance we have seen from the NEBU 602 COM 1H.

This request is necessary to continue gathering well pressure vs production data under similar conditions as the NEBU 602 COM 1H to help maximize recovery and help inform future well placement and completion designs. Although four new wells are located in relatively close geographic proximity to each other, data collection is needed from all of them (NEBU 604 COM 1H, NEBU 604 COM 2H, NEBU 604 COM 3H, and NEBU 605 COM 2H) as they each have notable reservoir and design differences. These variations are evident, as different performance is seen compared to the NEBU 602 Com 1H.
