Cement Surface Casing with 10bbls fresh water spacer, 39 bbls of 15.8 ppg type G cement (185sx), drop plug and displace with 23.7 bbls fresh water. Bump plug at 182 psi, float holding. Returned 19 bbls cement to surface.
