12/29/18- TD 8-1/2" @ 15420'

12/31/18- Run 5-1/2" Production Casing , 361 Jts of 5-1/2", 17# P-110, LT&C, csng set @ 15406', frac initiation sleeve (PBTD) @ 15272'. Cement PROD CSG with Halliburton. Held PISM and tested lines to 5,000 psi. Pumped 10 bbls fw spacer, 60 bbls tuned spacer at 11.5 ppg, 202.4 bbls (595 sx) Lead cement at 12.5 ppg, 516 bbls (2130 sx) of Tail cement at 13.3 ppg. Dropped (2) top plugs and displaced with 355.3 bbls of FW (1st 40 bbls with MMCR). Maintained returns throughout cement job. Plug bumped and floats held. **Circulated 55 bbls cement to surface.**
