

1/2/2019 - MIRU BWD 105. Unseat pump. POOH w/ rods and pump. ND WH. NU BOP install sub and TIW valve in tbg hanger. Close pipe rams. SWI. SDFN.
1/3/2019 - Pull tbg hanger. Tag 21' of fill at 5882'. PBTD at 5903'. TOH w/ 183 jts 2-3/8" tbg, SN, and mule shoe. Tally and RIH w/ 3-3/4" mill to 4062'. Put air unit on, unload hole 91' below bottom perf. TOOH w/ mill to depth of 3384'. Liner top at 3432'. SWI. SDFN.
1/4/2019 - TIH from 3384' to 4865'. Put air unit on and unload. TIH from 4865' to 5482'. This is 394' above bottom perf and 1267' below top perf. Put air unit on, but unable to get fluid to surface due to volume of air. It was decided to not clean out the 21' of fill as all perfs are open. TOOH and TIH w/ 32' price type mule shoe, 1.78" ID SN, 186 jt 2-3/8" 4.7# J-55 tbg. Land at 5806.57', SN at 5773'. ND BOP. NU WH. SWI. SDFWE.
1/7/2019 - Surf test insert pump. TIH on 3/4" SRS. Space out pmp, PU polish rod, seat 2" x 1-1/4" x 20' x 20'3" insert pmp. PRTS tbg to 650 psi w/ rig pmp. Stroke test insert pump to 500 psi. Test ok. Install HH and hand well on **RD RR BWD 105 @ 11:30 hrs on 1/7/2019.**
