The Lenis A Shane USA 001 well plug and abandonment was completed on 4/26/2016. This well is located on the same well pad with the Shane Gas Com 001 A API 30-045-22666 which is a BP active well and the Federal 29 9 14 002 API30-045-28263 well which is an active Southland Royalties well. All equipment associated with the Lenis A Shane USA 001 well has been removed; however final reclamation of the location cannot be performed until such time that the active wells are plugged and abandoned. On August 30, 2018 BLM Representative Randy McKee and BP Representative Sabre Beebe visited the location to discuss Final Abandonment completion. Mr. McKee concurred that the location cannot be reclaimed until the active wells are plugged and approved BP for FAN on the Lenis A Shane USA 001 well.
