On 10/30/18, Hilcorp Energy obtained permission from BLM and NMOCD to isolate the DK with CIBP @ 6382' and to produce the PC by itself for 90-days. Hilcorp Energy requests approval to extend the flow test on the PC for an additional 90 days and leave the DK isolated by the CIBP. The DK CIBP will be drilled out after 90 days and the well will be downhole commingled.
