PC Recompletion Procedure

1/16/2019

Procedure:

1. MIRU Service rig and associated equipment, test BOP.
2. TOOH w/ 2 3/8" tubing set at 6643'.
3. Set bridge plug at approximately 2217' to isolate existing perforations.
4. ND BOP, NU frac stack and test frac stack to frac pressure.
5. Perforate and frac the Pictured Cliffs. Estimated interval: 2029'-2117'.
6. Cleanout to isolation plug. Flow test PC.
7. Cleanout to PBTB.
8. TIH and land production tubing. Get a commingled flow rate.
9. Release service rig and turn well over to production.
