



Enduring Resources IV, LLC has ceased all on-lease operations associated with the referenced well as of July 2nd, 2019. The referenced well was scheduled for completion activity to begin on June 11th, 2019 and has been postponed until BLM completes the additional NEPA analysis and issues a new APD.
