Plug #1: CICR at 3004' KB. Spot 30 sx (34.5 cf) Class G in a balanced plug f 3004'-2683'. Confirm top w/ tubing

Plug #2: Spot 15 sx (17.3 cf) of Class G in a balanced plug f 1518' - 1288'. Confirm top w/ tubing.

Perforate 4 holes at 125', establish circulation out BH valve.

Plug #3: Pumped 32 sx (36.8 cf) of Class G for surface plug (125' - surface), good circulation to surface out BH valve.

Cut off well head below 7" casing collar. Top off 7"x4-1/2" annulus. Install 6' P&A marker on 4-1/2" casing.

Plugging operation witnessed by Ron Chavez with the BLM - Farmington FO.

Plan to start reclamation as per the approved plan within 90 days of this notice.
