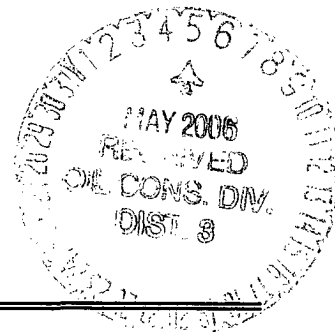

Elm Ridge Exploration Co, LLC reached a TD of 1508' on April 12, 2006. We ran 5 1/2" 15.5# J-55 LT&C casing to 1449'. Pumped 155 sks of STB B cement w/ 2% Econolite. Tailed in w/ 110 sks of STB B cement w/ 2% CACL. Circulated cement to surface w/ 10 bbls excess to surface. Pressure tested well to 1500 PSI.
