TUBING RULE

13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recompleat horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. Attach the Bond under which the work will be performed or provide the Bond No. on file with BLM/BIA. Required subsequent reports shall be filed within 30 days following completion of the involved operations. If the operation results in a multiple completion or recompleat in a new interval, a Form 3160-4 shall be filed once testing has been completed. Final Abandonment Notices shall be filed only after all requirements, including reclamation, have been completed, and the operator has determined that the final site is ready for final inspection.)

XTO Energy Inc. requests exception to Rule 19.15.3.107 (J2) requiring all wells equipped with casing larger in size than 3-1/2" OD be tubed. XTO requests the New Mexico Federal N #1G be produced with no tubing due to high pressure in the well. By producing this well without tubing, we will incur no waste. XTO Energy anticipates producing without tubing for approximately 90 days.

- A minimum of 2 valves capable of shutting in this well will be required.
