Pumped preflush of 6 bbls H2O, ahead of 68 sx (108 cf - 19.2 bbl slurry) Type I-II Portland cement with 20% flyash. Dropped plug and displaced w/13.8 bbls H2O. Circ. 1/2 bbl to surface. WOC. Cement fell back. Installed WH. RD Mote. 4/22/06 tagged cement w/11' of 3/4" PVC pipe. Mixed and pumped 3 sx (4.1 cf - 3/4 bbl slurry) Neat cement - topping and brought cement to surface. The casing PT will be conducted by the drilling rig and results shown on next report.
