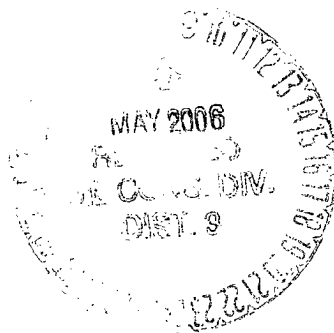

Cement with 225 sks Class B, 2% CaCl2, 1/4#/sk flocele (265 cu.ft.). Plug down @ 11:55 am on 04/26/06. Circulate 15 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing & BOP to 600 psi - ok.
