Cement first stage with 160 sks Class B, 5#/sk gilsonite, 1/4#/sk floccle (198 cu.ft.). Plug down @ 12:00 pm on 04/23/06. Circulate 10 bbls cement to surface. Circulate between stages. Cement second stage with 250 sks 65/35 Class B poz, 6% gel, 2% CaCl2, 10#/sk gilsonite, 1/4#/sk floccle tailed by 100 sks Class B, 5#/sk gilsonite, 1/4#/sk floccle (812 cu.ft.). Plug down @ 5:00 pm on 04/23/06. Circulate 12 bbls cement to surface. RD Halliburton. ND BOP. Release rig on 04/26/06. Will test casing during completion.
