**Plug #1 (2956' - 2953')**: CICR at 2956' KB. Spot 25 sx (29.5 cf) of Class G in a balanced plug f' 2956'-2953'. Run CBL f' 2953'- surface. Found TOC at ~ 2500'. Pressure test on casing failed.  
**Plug #2 (1529'-1278')**: Spot 20 sx (23.6 cf) of Class G in a balanced plug (confirm top at 1278' w/ tbg.). Perforate 2 holes at 152', establish circulation out BH valve.  
**Plug #3 (152'-Surface)**: Pumped 65 sx (76.7 cf) of Class G for surface plug. Circulated good cement out BH valve.  
 Cut off wellhead and top off surface casing x 4-1/2" annulus. Install 6' P&A marker on 4-1/2" casing.  
 Plugging operation witnessed and approved by Leo Pacheco w/ BLM - Farmington FO  
 Plan to start reclamation as per the approved plan within 90 days of this notice.
