Epic Energy, LLC, permanently plugged and abandoned the Mobil Apache #17 on September 18 - 19th as follows:

- Plug #1 (3052' - 2298')**: CICR at 3052' KB. Spot 50 sx (59 cf) of Class G in a balanced plug f' 3052'-2375'. Run CBL f' 3052'- surface. Found TOC at ~ 2000'. Pressure test on casing passed, TIH and confirm top of plug #1 at 2298' w/ tbg. Perf 3 holes at 1436'. RIH & set CICR at 1383'.
- Plug #2 (1436' - 1236')**: Pump 37 sx (43.6cf) of Class G (26 sx below CICR & 11 sx on top). Est. TOC behind casing at 1186'. Perforate 2 holes at 175', establish circulation out BH valve.
- Plug #3 (175' - Surface)**: Pumped 65 sx (76.7 cf) of Class G for surface plug. Circulated good cement out BH valve.

Cut off wellhead and top off surface casing x 4-1/2" annulus. Install 6' P&A marker on 4-1/2" casing. Plugging operation witnessed and approved by Darrel Priddy w/ BLM - Farmington FO. Plan to start reclamation as per the approved plan within 90 days of this notice.
