Plug #1 (2619' - 2132'): CICR at 2619' KB. Spot 30 sx (35.4cf) of Class G in a balanced plug f' 2619'-2132'. Pressure test to 500 psi - held good. TIH and confirm top of plug #1 at 2132' w/ tbg.

Plug #2 (1202'-1031'): Spot 13 sx (15.3 cf) of Class G in a balanced plug.

Plug #3 (257' - Surface): Pumped 65 sx (76.7 cf) of Class G for surface plug.

Cut off wellhead and top off surface casing x 4-1/2" annulus. Install 6' P&A marker on 4-1/2" casing. Plugging operation witnessed and approved by Derrick McCuller w/ BLM - Farmington FO. Plan to start reclamation as per the approved plan within 90 days of this notice.
