

- Allocated Gas production off lease, MCF: $\{(W_1-R_1)/((W_1-R_1) + (W_2-R_2) + (W_n-R_n))\} * (V)$
- On lease fuel usage, MCF. Determined from equipment specification and operating conditions. This includes, but is not limited to, compression, vapor recovery unit (VRU) compression, burners, and pump jacks.
- Lost and/or vented gas from well and/or lease equipment, MCF. Calculated using equipment and piping specifications and operating pressures.
- Allocated fuel from gathering system equipment, MCF. The total fuel required to operate gathering system equipment will be allocated to the individual wells benefiting from the equipment using allocation factors determined by $\{(W_1-R_1)/((W_1-R_1) + (W_2-R_2) + (W_n-R_n))\}$.
- Allocated volume of gas lost and/or vented from the gathering system, gathering system equipment, condensate collection, and water collection in MCF. The total volume will be determined using industry accepted procedures the time of the loss. The total volumes lost and/or vented will be allocated to the individual wells affected using factors determined $\{(W_1-R_1)/((W_1-R_1) + (W_2-R_2) + (W_n-R_n))\}$.



Individual Well BTU'S
