2/21/06 PT 7" casing to 1800 psi for 30 minutes. Good Test. TOC @ 82' determined by temperature log. Verbal approval given by Steve Hayden and Jim Lovato to continue drilling without remediation.

2/28/06 RU WL. Ran CBL from 7820' to 2240'. TOC @ 2490'.

3/1/06 Attempted to PT 4 1/2" casing. Tested to 5000#, leaked 100# in 1 minute. Isolated leak with PKR and BP @ 7513' (in Greenhorn). Could not establish injection rate. CBL ran, showed good bond above and below leak. Verbal given by Steve Hayden (OCD) and Jim Lovato - no remediation needed.
