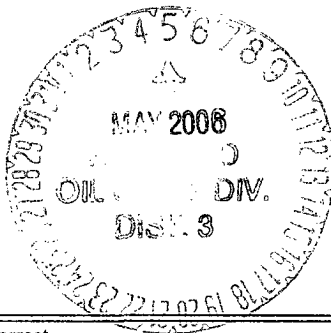

Devon Energy has completed the first Lewis zone from 4,800' to 5,107' on 11/5/06 with 842 bbl 68Q N2 Foam and 55,785# 20/40 Brady sand; second Lewis zone from 4,350' to 4,639' on 11/5/06 with 1414 bbls 68Q N2 Linear Gel and 90,885# 20/40 Brady sand. This zone has been successfully added to the existing Mesaverde zone. The well was returned to sales on x/x/x with tubing end at 7,757'.
