4/17/06 Hot water down tubing - pressured up to 500#. Pump hot water down the casing at 0.5 bpm at 760#. Work rods free. POH with 168 - 3/4" and 104 - 7/8" rods. Pump 25 bbls hot water down tubing.
4/18/06 NU BOP. Found tubing stuck. RU wireline unit and RIH with 1-13/16 GR to 2494'. Stack out on paraffin. Pump very hot water down tubing, circulate out casing. RIH with 1-11/16" GR to 2500'. RD wireline. Unable to get a coiled tubing unit.
4/19/06 LD rods and NU wellhead. RD and MOL. Plan to schedule a coiled tubing unit to clean out the tubing.
