05/12-13/06 Drilled 8 3/4" hole to 2975', ran 7", 23#, J-55 LTC casing, landed @ 2974' KB (KB=13.0). Pump lead cement 390 sks 12.1# Premium Lite FM cement, plus 3% CaCl, plus 0.25 lb/sk Celloflake, plus 5 lb/sk LCM-1, plus 0.4% FL-52, plus 8% Bentonite, plus 0.4% Sodium Metasilicate, yield 2.13, 830.7 cu.ft. Tail cement 86 sks 14.6# Type III cement plus 1% CaCl, plus 0.25 lb/sk Celloflake, plus 0.2% FL-52, yield 1.38, 118.68 cu. ft. We used centralizers every other joint above the shoe to the turbolizers. Ran 1 turbolizer at the base of the Ojo, and 1 turbolizer 1 joint up in the Ojo. Then centralizers every 400' to the surface pipe. Circulated 55 bbls of cement to surface. Wait on cement. Shut well in, waiting on completion rig.
