05/08/06 spud 8-3/4" surface hole. Drilled to 137'KB. Ran 6 jts (128.43') of 7", 20#, J-55, ST&C new LS casing and set casing at 134'KB. Cemented with 65sx (77 cu. ft.) of Cl "B", 3% CaCl₂ and 1/4 #/sk celloflake. Circulated 4 bbls of good cement to surface.

05/09/06 Nipped up the BOP and pressure tested the casing and BOP to 1500 psi.

05/11/06 TD 6-1/4" hole at 1890' . Ran 45 jts (1855.45') of 4.-1/2", 11.6#, L/S R-3, EUE 8rd production casing and landed at 1861.20' KB. Insert float is at 1838'KB. Cemented with 106 sx (330cu.ft.) of Type 5, 2% sodium metasilicate, 1/4#/sk celloflake, followed by 100 sx (118 cu. ft.) of Type 5, with 1/4# celloflake. Bumped plug to 1000 psi. Circulated 25 bbls of cement to the surface.
