







Pumped a preflush of 25 bbls FW w/dye in last 5 bbls. Pumped 190 sx (220 cf - 39.3 bbl slurry) Class G cement w/2% CaCl₂, .25#/sx Cellophane. Release wiper plug and displaced w/14.7 bbls FW. Bumped plug w/641 psi. Circ. 15 bbls good cement to surface. WOC. NU WH & BOP. PT casing, rams and manifold to 1500 psi for 30 minutes. Good test.
