RIH w/4-1/2", 10.5#, J-55 casing and set @ 7875' w/marker joint @ 4985-5005'. RU Halliburton to cement. Pumped a preflush of 200 bbls 2% KCl. Pumped 525 sx (76 cf (135.52 bbl slurry) 50/50 STD, POZ, 3% Bentonite gel, 0.2% CFR-3, 0.1% HR-5, 0.8% HALAD-9, 5#/sx Pheno-seal. Displaced w/122 bbls 2% KCl. Plug down @ 2130 hrs 7/4/03. No cement circulated to surface; (none planned). RD Halliburton. ND BOP, set slips and cut off casing. Installed trash cap. RD & released rig 0600 hrs 7/5/03. Will show TOC and casing PT on next report.
