Verbal approval was granted by the BLM on April 28, 2006 to change BOP due to Coil Tbg Unit.

The CTD Unit has a slightly different BOP configuration from our conventional drilling rigs. Instead of the 11" x 3,000 psi blind ram & annular configuration; the CTD is equipped with an 11" x 5,000 psi blind/shear ram & annular stack. Because we are drilling into the underpressured Coal & PC only, we would like to limit our test pressures to 250 psi/ 750 psi. Please see the attached schematic from Knight Oil Tool Rentals.
