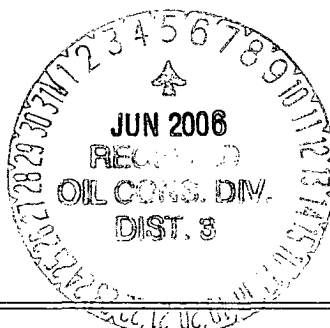

On 4/22/06, set 9 jts of 5 1/2", J-55, 15.5#, LT&C Liner, run to 3,477' with 0 sx of cement. Top of liner hanger is at 3,094'. Perforations are from 3,155' - 3,391', 4 SPF, 0.55", 312 holes, 120 degree phasing. On 4/23/06 ran back in hole with 106 jts of 2 3/8" tubing J-55, 4.7#, LT&C, end of tubing set at 3,467', return well to sales on 4/23/06.
