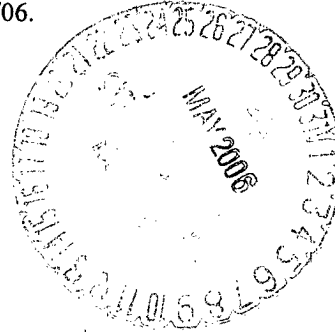

On 5/10/06, ran in hole with 10 jts of 5 1/2", J-55, 15.5#, LT&C Liner was run to 3,438' with 0 sx of cement. Top of liner hanger is at 3,021'. Perforations are from 3,070' - 3,352', 4 SPF, 0.55", 344 holes, 120 degree phasing. On 5/11/06 ran back in hole with 104 jts of 2 3/8" tubing J-55, 4.7#, LT&C, end of tubing set at 3,423', return well to sales on 5/11/06.
