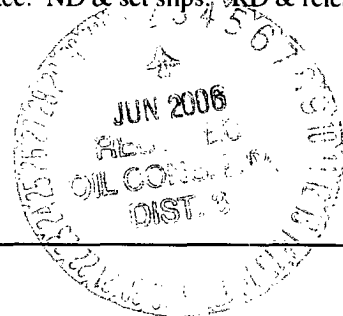

5/16/06 RIH w/directional tools & 8-3/4" bit & tagged cement @ 170'. D/O cement to 240'. Drill & survey while sliding & rotating. Drilled to intermediate TD @ 3610'. Circ. POOH & LD DP & BHA. RIH w/85 jts 7". 23# J-55 casing and set @ 3610'. RU to cement. Pumped preflush of 30 bbls FW & gel. Pumped 450 sx (1305 cf - 232 bbl slurry) Class G w/3% Econolite, 1/4#/sx Flocele, 6#/sx Gilsonite. Lead cement & Tailed w/100 sx (133cf - 23 bbl slurry) Class G w/2% Gel, 2% CaCl, 1/4#/sx Flocele, 5#/sx Gilsonite. Dropped plug and displaced w/140 bbls FW. Circ. 50 bbls good cement to surface. ND & set slips. RD & released 5/21/06.

Will report casing PT on next report. The PT will be conducted by the completion rig.
