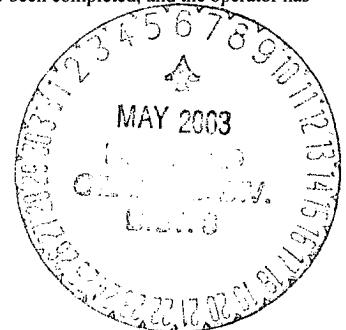

2. Spot 28 cu ft of Class "B" cement on top of CIBP to P&A the Pictured Cliffs (top @ 3498'), Fruitland Coal (top @ 3397') & Ojo Alamo (top @ 3235') formations
3. Perforate 4-1/2" casing @ 148' (7" surface casing shoe @ 98').
4. Circulate Class "B" cement to surface inside & outside 4-1/2" casing (70 sx - 100% excess).
5. Set dry hole marker.
