Basin Dakota: Water: 47% Oil: 59% Gas: 76%

Blanco Mesaverde: Water: 53% Oil: 41% Gas: 24%

Ownership is common between pools & notice to owners was unnecessary. DHC will offer an economical method of production while protecting against reservoir damage, waste of reserves & protection of correlative rights. The NMOC has been notified of our intent via submission of form C103.
