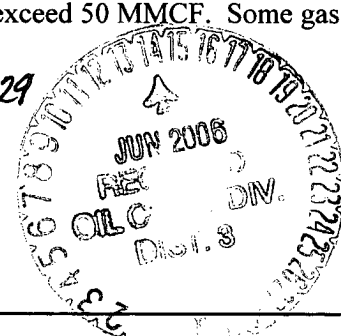

This well was completed Nov 29, 2005. For the purpose of de-watering the Coal Formation, and while waiting on sales line construction/connection (WO BLM Pipeline ROW), SG Interests is requesting approval to vent coal gas to the atmosphere for ~~30~~ 60 days in addition to the allowed testing (venting) period of 60 days, with total volume not to exceed 50 MMCF. Some gas has been vented at the rate of 5 MCFPD.
