13. Describe Proposed or Completed Operations

Golden Oil worked on this well from May 8<sup>th</sup> through 18<sup>th</sup>. After fishing out the parted tubing, the casing did not test. Casing leak(s) were found from 3774' to 4576'.

Since the well has not produced for several years, Golden Oil plans to do a 180 day economic test to determine if sufficient production can be realized to justify the expense of a major casing repair workover.

If the production level is sub economic, then the well will be promptly plugged and abandoned.

## **Workover Report**

### **Work Summary:**

- 5/8/06 MOL and RU. Pull rods. Hot oil tubing. Pull tubing, found parted at 4424'; heavy corrosion.
- 5/9/06 Tag fish at 4446'. Recovered 15' piece, parted again. Note tubing very, very corroded. Multiple holes. Heavy scale. Heavy scale in casing.
- 5/10/06 Tag fish at 4472'. Jar fish free. TOH and LD 89 joints 2.375" tubing, total 225 joints, from well.
- 5/11/06 Ran scraper, set RBP at 5720. Test casing, leak, 2 bpm at 400#.
- 5/12/06 Isolate casing leak(s) from 3774' to 4576'. Pull RBP. TIH with bit.
- 5/15/06 Circulate well with KCl water. Clean out fill from 7131' to 7335'. Set Loc Set packer at 7184' with on / off tool above.
- 5/16/06 Rods stacked out on paraffin in tubing. Hot oil again. Pull packer, replace rubber.
- 5/17/06 With packer at 7196', hot oil tubing again.
- 5/18/06 Land 226 joints 2.375" tubing at 7196' KB with Loc Set packer at 5590' and SN at 7161'. Ran 170 3/4" rods and 116 - 7/8" rods. Space out rod and hang off.
