Tail w/320sx 50/50 Class G POZ, .25#/sks D-029 Cellophane Flakes, 2% D-20 Betonite, 5#/sks D-024 Gilsonite Extender, 2% S-001 Calcium Chloride, .20% D-046 Antifoam (yield 406 cu ft). Displaced 100 bbl FWTR. Bump plug to 1600 psi. Plug down and holding @ 1:30am on 5/28/06. Circ 50 bbl of cement to surface. ND BOP. RD. Release rig.

Will report csg pt on next report. PT will be conducted by completion rig.
