Reached driller's TD of 7616' @ 12:00 a.m., 5/18/06.

Run 5-1/2", 15.5#, K-55, LT&C csg to 7615' KB. Cmtd 1st stage w/210 sx Prem Lite w/2% CD32, 1/2 pps Celloflake, 5% FL52 & 2% KCl (12.5 ppg & 2.01 cuft/sx) f/b 150 sx Type III cmt w/3% CD32, 1/2 pps Celloflake, 5% FL52 & 2% KCl (14.2 ppg & 1.45 cuft/sx). Circ 10 bbl cmt to surf. Cmtd 2nd stage w/360 sx Type III cmt w/8% Bentonite, 1/4 pps Celloflake & 2% LCM (11.9 ppg & 2.6 cuft/sx) f/b 100 sx Type III neat cmt (14.5 ppg & 1.39 cuft/sx). Circ 1 bbl cmt to surf.

Production csg will be tested upon completion.
