Reached driller's TD of 6685' @ 9:30 a.m., 5/14/06.

Run 5-1/2", 15.5#, J-55 casing to 6680' KB. Cmtd 1st stage w/250 sx Prem Lite w/0.2% CD-32, 1/2 pps Celloflake, 0.5% FL-52, 2% Phenoseal & 2% Potassium (12.5 ppg & 2.01 cuft/sx) f/b 150 sx Type III cmt w/0.3% CD-32, 1/4 pps Celloflake, 0.2% FL-52, & 2% Phenoseal (14.2 ppg & 1.48 cuft/sx). Circ 30 hbbs cmt to surf. Cmtd 2nd stage w/150 sx Type III cmt w/8% Bentonite, 1/4 pps Celloflake & 2% Phenoseal (11.9 ppg & 2.6 cuft/sx) f/b 100 sx Type III neat cmt (14.5 ppg & 1.39 cuft/sx). Circ 20 hbbs cmt to surf.

Production casing will be tested upon completion.
