5/26/2006 thru 5/31/2006: MIRU Roadrunner Well Service ("Roadrunner"). Load tubing, long stoke well and pressure test tbg. to 500 psig - ok. Rig down and release Roadrunner. Start well up using propane. Producing 10 BWPd.

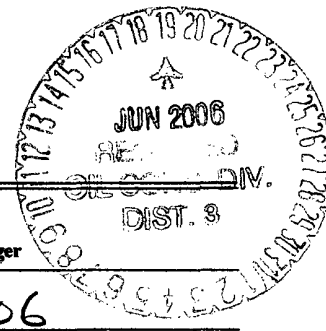
