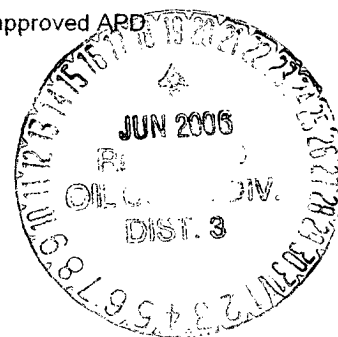
The new pipe program will be:
