

This well was completed 12/5/2005. For the purpose of de-watering the Coal Formation, and while waiting on sales line construction/connection (WO BLM Pipeline ROW), SG Interests is requesting approval to vent coal gas to the atmosphere for 30-90 days in addition to the allowed testing (venting) period of 30 days, with total volume not to exceed 50 MMCF. Some gas has been vented at the rate of 15 MCFPD.
