The surface hole size will be 8 3/4" instead of 8 5/8", and the surface casing will be 7", 23#, LS, LT&C.

The production hole size will be 6 1/4" instead of 6 3/4", and the production casing will be 4 1/2", 11.6#, LS, LT&C.

All other aspects of the APD package will remain the same.
