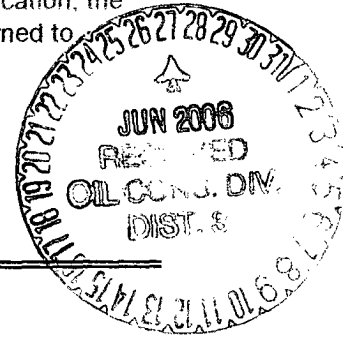

13. Describe Proposed or Completed Operations (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. Black Hills Gas Resources intends to pull 2 3/8" tubing and set a retrievable bridge plug in 5-1/2", 17#, N-80 casing above Pictured Cliffs perforations as a safety precaution while another well is being drilled on the same pad location to the Dakota formation. A mechanical integrity test will be performed and BLM and NMOCDD will be notified prior to test in order to witness. Once the drilling is completed and the drilling rig moves off location, the retrievable bridge plug will be pulled, the 2-3/8" tubing will be run and Jicarilla 464-29 #16 will be returned to production in the Pictured Cliffs.
