Displaced w/14 bbl wtr. No cmt to surface. Pumped 21sx Type I-II NEAT (29.19 cu ft) through flush jnt pvc. RDMO.

06/20/06 MIRU. NU BOP. PT-ok. PT csg 1000#/30 minutes. Test ok. RIH w/8 3/4" bit, tagged cmt @ 191ft. Drill out cmt and drill ahead.

06/21/06 Drill ahead to 2920' TD. Circ hole clean. RIH w/67 jnts 7", 20#, J-55 ST&C casing and set @ 2910'. Circ.

06/22/06 RU to cmt. Pumped 20 bbl of FW & Gel. Cmt'd w/385sx Class G cmt w/3% D-079, 2% D-46, .25#/sks D-29 (993.3 cu ft). Tail in w/100sx 50/50 G-POZ w/2% D-20, .1% D-46, .5#/sks D-24, 1%, .3% D-65, .25#/sks D-29 (125 cu ft). Drop plug and displace w/116 bbl of FW. Bump plug to 1600psi. Circ 50 bbl cement to surface. PT will be conducted by completion rig.
