Pumped 11sxs(26cu-5bbls)/Type 5 cmt w/3% CaCl2 and .25 pps of Cell-o-Flake. Followed w/220sxs(260cu-46bbls)/Type 5 cmy w/3% CaCl2, .25pps Cell-o-flake. Drop plug and displace w/13bbls H2O.
