BLACK HILLS requests administrative approval to downhole commingle the East Blanco Pictured Cliffs (72400) & Basin Fruitland Coal (71629).

Both intervals have common ownership & produce essentially dry gas. We have not experienced any significant cross flows between the intervals, & all the fluids are compatible. Downhole commingling will improve recovery of liquids & gas. **CONDITIONS OF APPROVAL** eliminate previously issued stipulations, & maximize productivity. Notice has been filed concurrently on form C-107A with the State.

These Gas & Oil allocations are based on choke tests taken during rig operations in August 2005, in which the FRTC flowed 47 MCF/D & the PC & FRTC together flowed 145 MCF/D. See attached calculations. This FRTC pool does not produce oil.

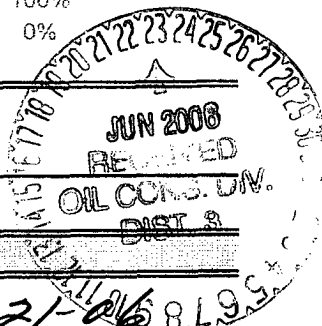

Commingle Allocation Calculations

OIL

The Basin Fruitland Coal gas pool does not make any oil in the vicinity of the subject well. The East Blanco Pictured Cliffs gas pool does produce a little oil. Therefore, any and all oil will be assigned to the Pictured Cliffs.

GAS

During workover operations in July & August 2005, stabilized choke gas tests were taken on the FRTC alone, then on the FRTC and Pictured Cliffs together.

Choke gas test on FRTC alone: 47 MCF/D.

Choke gas test on Pictured Cliffs and FRTC together: 145 MCF/D.

Total gas = 47 + 145 = 192 MCF/D.

$$\% \text{ Pictured Cliffs} = \frac{192-47}{192} = 76\%$$

$$\% \text{ FRTC} = \frac{47}{192} = 24\%$$
