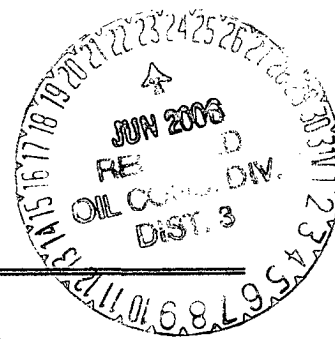

This gas well was 1st delivered to the Black Hills gathering system on 6/22/05. The Pictured Cliffs and Fruitland Coal are commingled and produce up the tubing from below a packer, and the Kirtland and Tertiary are commingled and produce up the annulus above the packer.
