Drilled 12 1/4" hole to 300' on 5/7/06, set 9 jts of 9 5/8", H-40, ST&C, 32.3# casing at 292'. Cemented w/175 sx (37 bbls) "B" cement w/2% CaCl and 1/4# PSX Floeal. Circulated 15 bbls of cement to surface. Test casing to 1,500 psi.

Drilled 8 3/4" hole to 3,760' on 5/11/06, set 86 jts of 7", J-55 LT&C, 23# casing at 3,750'. Cemented lead w/550 sx (142 bbls) 50/50 POZ cement w/3% Gel, 5# Gilsomite, 1/4# Flocele, 0.1% CFR 3, 0.4% Halad 344 and tail w/75 sx (19 bbls) STD "B" cement w/0.4% Halad 344. Circulated 31 bbls of cement to surface. Tested casing to 1,500 psi.

Drilled 6 1/4" hole to 8,195' on 5/15/06, set 193 jts 4 1/2", J-55, LT&C, 11.6# casing at 8,192'. Cemented lead w/485 sx (127 bbls) 50/50 POZ w/2% Gel, 2/10% Veraset, 1/10% Diacel LWL. Trace cement to surface. Landed 2 3/8" production tubing at 8,110'.
