Ran 2-3/8" 4.7# J-55 tbg & latched on to on/off tool @ 3669'. Swab tested 0 MCF/D. Released pkr-did not pull. Latch back on to on/off tool w/2-3/8" tbg & initiate pumping. Released workover rig 8/12/05.
