7/1/06 MIRU Aztec#469. NU BOP. PT blind rams and casing to 1500#/30 min. ok. RIH w/6 1/4" bit and tagged cmt. TOC @ 3119'. D/O cmt shoe and then formation to 3448' (TD). TD reached 7/6/06. Ran pitot test. RIH w/5 1/2" 20# J-55 pre-perf'd liner and set @ 3448' w/TOL @ 3123' (47' overlap into 7" shoe). Perfs @ (3171'-3214'=43'; 3383'-3446'=63')=106'=212 holes. PU perf mill and milled out perf plugs. Circulate clean. RIH w/108jts 2 3/8" 4.7# J-55 tubing and set @ 3441' w/SN @ 3440'. ND BOP RD and released 7/12/06 @ 1700hrs.
