3/9/06 MIRUSU: Pressure test casing to 4000 psi - OK. Spot 250 gallons acetic acid across proposed PC perfs. Ran CBL. TOC @ 200'. Perf PC @ 3862'-70' w/4 SPF. Frac PC w/38,700# sand in 75Q slick foam. Clean out after PC frac and test well on 3/14/06 on 1/2" choke for 16 hrs. at an average 55 psi for 438 MCF/D. Set RBP @ 3600'.

Perf Tertiary (Nacimiento) @ 2871'-75', 3012'-20', 3126'-30', 3309'-12' w/4 SPF. Using RBP & PKR, breakdown each set of Tertiary perfs with total of 700 gallons HCL acid. Tested Tertiary on 3/21/06 on 1/4" choke for 50 MCF/D. Release RBP @ 3600' and TOH. Clean out to 4007'. Land 2-3/8" 4.7# J-55 tubing @ 3957'. Ran pump and rods. Released rig 3/25/06.
