13. Describe Proposed or Completed Operations

We intend to penetrate casing of the San Juan 30-6 Unit #427S with a high-pressure water-jet from 3,443-3,463 (in the 7" casing above the 5-1/2" liner top). We have determined the top of the Fruitland Coal interval to be 3,443' in this wellbore. We have chosen the #427S as a mechanical test wellbore for this new technology and do not intend to increase production as a result of penetrating the casing at this interval. Furthermore, we are currently seeking partner approval to plug and abandon the #427S to satisfy the demand on this well due to inactivity of 1yr by August/06. A P&A procedure will be submitted and approved prior to commencing the P&A procedure.

Workover Pit will be required for this project.
